## Michael Hill

Michael, 55, has been a member of Roehampton Club since 2003 and he is an active squash, tennis, gym and occasional golf playing Member. He has represented the Club at squash since joining and was section Captain from 2017 to 2020. Michael and his family have all been active Members and his three children have grown up at the Club and been active Tennis and Squash players.

Michael retired in 2016 and is Founder and Chairman of Rackets Cubed. It runs integrated Racket Sports, (STEM/Maths) Education and Nutrition Programmes for inner-city school children in areas of high disadvantage.
