Teams in Action

Penalty Areas

Under the current version of the Rules, the previous categories of lateral and vertical hazard have been replaced with red and yellow Penalty Areas. These areas are marked out on the course by the appropriate coloured stakes. Rule 17 covers penalty areas, and notes that:

- the player may play the ball as it lies without penalty, under the same Rules that apply to a ball in the general areas (which means there are no specific rules limiting how the ball may be played; in the old days, the player was prohibited from grounding her club, among other restrictions)



- The player may stand in a penalty area to play a ball outside the penalty area, including after taking relief (please note the difference to a ball in GUR, which precludes the player from standing in the area)
 - Note that the exception to the above is if the Golf Committee has designated the area where the ball has landed as a No Play Zone, in which case the player must take relief as outlined below; the player may not hit out of nor stand in a No Play Zone

If the player's ball is not found, but it is known or virtually certain that it entered a penalty area:

- The player may take penalty relief
- Once the player puts another ball in play by taking relief, the original ball is no longer in play and must not be played, even if it is then found on the course before the end of the three-minute search time

If it is not known or virtually certain that the ball came to rest in a penalty area, and the ball is not found, the player must take stroke and distance relief, by returning to hit a new ball from the spot of the original shot.

Although it is equally annoying to land in either a red or yellow penalty area, it is important to note the differences in how a player may take relief. In both types of penalty areas, the player may take relief, at the cost of one penalty stroke, by:

- Stroke-And-Distance-Relief, playing the original ball or another ball from where the previous stroke was made
- Back-On-The-Line-Relief, dropping the original ball or another in a relief area that is based on a reference line going straight back from the hole through the estimated point where the original ball last crossed the edge of the penalty area (see Rule 17.1d for more details); note that the relief area may only extend one club length back along this line, and must not be inside the penalty area

In a penalty area marked by red stakes only, the player has a third dropping option:

- When the ball last crossed the edge of a red penalty area, the player may drop the original ball or another two club lengths, not nearer the hole, from the point where the ball entered the area.
